



Pistol Range Rules

1. All Shooters must sign in at the store **Before** entering & **After** leaving the range.
2. Pistols **ONLY** on this range. Absolutely **NO** rifles, shotguns, or shotgun ammunition is allowed on the pistol range.
3. Ear & Eye protection is required at **ALL** times while on the range.
4. **BEFORE** going down range, notify **ALL** shooters and unload **ALL** guns.
5. **ALL** weapons must be holstered or in a bag when not firing.
6. **DO NOT** move targets.
7. Shoot at targets attached to backstops. **DO NOT** place items on the ground to shoot at.
8. **NO** rapid fire.
9. Tobacco products, alcohol, and/or drugs are **PROHIBITED** on the range.
10. **NO** cursing on while on the range.
11. **NO** horseplay on the range at any time.
12. Please notify staff of any repairs needed.

***Any violators of the above rules will be asked to leave and will not be allowed to return to this range. Any member in violation of these rules will be asked to leave and will forfeit their membership and paid membership dues.*

Rifle Range Rules

1. All Shooters must sign in at the store **Before** entering & **After** leaving the range.
2. Rifles **ONLY** on this range. Absolutely **NO** pistols, shotguns, or shotgun ammunition is allowed on the rifle range.
3. Ear & Eye protection is required at **ALL** times while on the range.
4. **BEFORE** going down range, notify **ALL** shooters and unload **ALL** guns.
5. **ALL** weapons must be locked back with the bolt open when not firing. Safety flags or cable locks must be inserted in bolt when not firing.
6. **DO NOT** move targets.
7. Shoot at targets attached to backstops. **DO NOT** place items on the ground to shoot at.
8. **NO** rapid fire.
9. Shoot from a seated position at one of the benches in the shooting house.
10. Tobacco products, alcohol, and/or drugs are **PROHIBITED** on the range.
11. **NO** cursing on while on the range.
12. **NO** horseplay on the range at any time.
13. Please notify staff of any repairs needed.

***Any violators of the above rules will be asked to leave and will not be allowed to return to this range. Any member in violation of these rules will be asked to leave and will forfeit their membership and paid membership dues.*

RELEASE AND HOLD HARMLESS AGREEMENT

The undersigned, being at least 18 years of age, or a minor (under the age of 18 years of age) and the minor's parent or legal guardian signing in an individual capacity and on behalf of the minor, in consideration of the rates charged and the right to enter and use the services, facilities and shooting range(s) of Sandy Run Outdoors, LLC (hereinafter referred to as "SRO") do hereby enter into this Release and Hold Harmless Agreement (hereinafter referred to as "Agreement") and consent and agree as follows:

1. **POSSESSION OF A FIREARM.** I acknowledge that at the time of signing this Agreement, I am in sufficient physical and mental condition to engage in sport shooting. I am not a fugitive from justice. I have not been convicted of a felony or other crime that would prevent me from owning or possessing a firearm and I am not under adjudication of mental incompetence.

2. **ACKNOWLEDGEMENT OF DANGER.** I acknowledge that engaging in sport shooting is dangerous. I further acknowledge that no matter what precautions I may take, including but not limited to the wearing of various types of protective gear (including hearing and eye protection), that I could experience injury of a very serious nature and/or die as a result of an accident or incident. I therefore engage in such activities voluntarily and at my own risk.

3. **ASSUMPTION OF RISKS.** I acknowledge and represent that I am familiar with the significant risks and dangerous nature, including but not limited to causing death or serious bodily injury to myself and others, and causing damage(s) to property, which originates from participating and otherwise engaging in sport shooting. I hereby assume any and all responsibilities and liabilities pertaining to such risks, whether to myself or to others and without limitation or qualification.

4. **RELEASE.** I do hereby (and, if applicable, parent or legal guardian does hereby on behalf of minor) on behalf of myself and my heirs, executors, assigns and legal and personal representatives, unconditionally and irrevocably release and discharge SRO, its successors, assigns, owners, shareholders, directors, officers, employees and agents and all persons acting by, through, under or in concert with any of them, from any and all liability for personal injury, death or property damage arising out of the use, by me or any third party, in any way, of the range, its equipment or firearms, or my firearm or caused by any reason whatsoever related to SRO and my sport shooting at the range(s) on or about SRO premises and facilities.

5. **INDEMNIFICATION.** I hereby agree to indemnify SRO against, defend (with counsel acceptable to SRO) and to hold SRO and its successors, assigns, owners, shareholders, directors, officers, employees and agents and all persons acting by, through, under or in concert with any of them harmless from all claims, demands, causes of action, losses, damages, liability, costs and expenses (including, without limitation, attorney's fees) asserted against or incurred by SRO, its successors, assigns, owners, shareholders, directors, officers, employees and agents and all persons acting by, through, under or in concert with any of them, by any third party in connection with or arising out of this Agreement, or for any negligent or intentional conduct on my behalf.

6. **GOVERNING LAW.** This Agreement shall be governed by, and construed in accordance with the laws of the State of South Carolina. I agree that this Agreement is intended to be as broad and inclusive as is permitted by the law of the State of South Carolina and that if any portion of this Agreement is held invalid, I agree that the balance shall continue in full legal force and effect.

7. **MINORS.** If signing on behalf of a minor, I acknowledge, as the parent and legal guardian of said minor, that the minor shall be bound by the terms of this Agreement. I understand and agree that if this Agreement is not signed on behalf of the minor, the minor would not be permitted to use the services and shooting range(s) of SRO.

8. **RANGE RULES AND REGULATIONS.** I have read and understand and agree to follow the SRO shooting range rules and regulations, a copy of which has been provided to me by SRO.

The undersigned has read and voluntarily signs this Agreement and further acknowledges and agrees that no oral representations, statements of inducements apart from this Agreement have been made by SRO.

Rules & Regulations for the Range (as of 8/9/2018)

- _____ New Hours: Monday – Saturday 9:00 a.m. To 4:00 p.m. That means no one will be allowed on either range before 9:00 a.m. All people must be off both ranges and check back in at the store at 4:00 p.m.
- _____ There are only four (4) people allowed on the rifle range at any one time and only three (3) people allowed on the pistol range at any one time.
- _____ You must be 21 years of age or older to use the range or accompanied by someone who is 21 years of age or older.
- _____ There are **NO SPECTATORS** allowed on the range. Exception: One (1) child may accompany his/her parent.
- _____ You must check in at store after leaving rifle range or pistol range if going to both.
- _____ There is **NO REPETITIVE OR RAPID FIRING** allowed on either range. If we hear it you will be asked to leave and not allowed to return.
- _____ **DO NOT** throw brass into the trash cans. If you choose to pick up the brass there are buckets at both ranges to put the brass in; otherwise leave it on the ground and our range keeper will clean it up.
- _____ There is absolutely **NO HORSE PLAY** on the ranges
- _____ The metal targets on the pistol range must stay against the berm, do not move them.
- _____ (*Addendum 3/25/2019*) If the Rifle/Pistol Range is Hot, **DO NOT** stand behind anyone who is firing their weapon.
- _____ Any violators of the above rules will be asked to leave and will not be allowed to return to this range. Any member in violation of these rules will be asked to leave and will forfeit their membership and paid membership dues.
